At present some of your personal details will be kept as a matter of record by SADAC. They are your Name(s), Address, Telephone Numbers & Email Addresses.

Under the GDPR, Swanage & District Angling Club Limited ensures full membership details are subject to access only by the directors/ Committee responsible for finance and secretarial matters and are subject to security controls. This personal data is not kept for longer than is required by the purpose for which the information was gathered. Our subscription year is a calendar year. If you do not pay a subscription within any calendar year your membership record will be deleted on 31 December.

No data can be transferred, even for a legitimate purpose, outside of the EEA (most of Europe) <u>except with</u> <u>the specific consent of the individual.</u> This is particularly important when putting information on the Web which can be accessed from anywhere. <u>Consent must first be obtained.</u>

SADAC uses social media, and we need consent from club members in certain circumstances to be able publish their names and images. These circumstances would include publishing the results of our fishing competitions, end of year trophy winners and any other information that promotes sea angling as a sport. There are also occasions where we will share this information and images with the local press and possibly other media, such as fishing magazines etc.

SADAC also uses WhatsApp messaging to keep members informed with club related matters and general inter-member communication. This requires a member's mobile number. Only those members that <u>opt in</u> to use WhatsApp messaging will be granted access to the group. Once opted in, you can leave at any time.

As a member you can access your personal information upon written request. Without your consent we will not publish your details. You also have the right to withdraw or restrict your written consent at any time.
